

**Business Items for the
Regional Assembly of the
Christian Church (Disciples of Christ) in Georgia
Meeting November 6 & 7, 2009 at Cherry Log Christian Church**

Business Item #1 Regarding Special Day Offerings and DMF distribution:

It is recommended by the Regional Board that the Regional Assembly of the Christian Church in Georgia meeting November 6&7, 2009 at Cherry Log Christian Church approve the following for distribution of Special Day Offerings and Disciple Mission Fund giving from Georgia. For funds received during 2010:

Special Offerings received by congregations and forwarded through the Christian Church in Georgia be allocated according to the General Board recommendations:

- a. Easter for General Church ministries
- b. Pentecost for New Church ministries (50% in Georgia, 50% General)
- c. Thanksgiving for Higher Education ministries
- d. Christmas for Regional Ministries in Georgia
- e. Week of Compassion for Disaster Relief and Development
- f. Reconciliation for Antiracism ministries (80% in Georgia and 20% national – as per SERF negotiations)

And that Disciple Mission Fund dollars received form Georgia sources be divided as follows:

- 60% for Christian Church in Georgia
- 6% Office of General Minister and President
- 34% for General Ministries and Higher Education institutions

Business Item # 2 Regarding the Regional Operating Budget for 2010

It is recommended by the Regional Board that the Regional Assembly of the Christian Church in Georgia meeting November 6&7 at Cherry Log Christian Church, approve the operating budget for the Christian Church in Georgia for 2010 as presented to the Assembly.

Business Item #3 Regarding the Budget for Camp Christian Conference Center for 2010

It is recommended by the Regional Board that the Regional Assembly of the Christian Church in Georgia meeting November 6&7 at Cherry Log Christian Church, approve the budget for Camp Christian Conference Center for the year 2010 as presented to the Assembly.

Business Item #4 Regarding the Election of Officers and Regional Board Members

It is recommended by the Regional Board that the Regional Assembly of the Christian Church in Georgia meeting November 6&7 at Cherry Log Christian Church, approve the Nominating Committee Report and that the people named in it be elected these positions

Business Item #5 Regarding the Ratification of Board Members for the Christian College of Georgia.

It is recommended by the Regional Board that the Regional Assembly of the Christian Church in Georgia meeting November 6 & 7 at Cherry Log Christian Church approve the slate presented by the Christian College of Georgia for positions on their board.
